

## Cats Aren't Trophies

Protecting Colorado's mountain lions, bobcats & lynx

**CATs is a diverse statewide coalition promoting a ballot measure to ban trophy hunting of mountain lions and commercial fur trapping of bobcats in Colorado. Lynx are included as a rare wild cat species of Colorado because they are inadvertently injured and killed in baited bobcat traps or chased and attacked by packs of dogs set loose after lions or bobcats.**


**Trophy hunting of mountain lions and bobcats is cruel and unsporting – a highly commercial, high-tech head-hunting exercise that doesn't produce edible meat or sound wildlife management outcomes, but only orphaned cubs and social chaos among the surviving big cats.**

### Holiday Greetings from the frontlines of the CATs campaign!

CATs is entering the holidays celebrating a modest but meaningful victory for Colorado's mountain lions! At its most recent meeting, the Colorado Parks & Wildlife Commission banned the use of electronic calls for mountain lion trophy hunting. While this win gives cause to celebrate while we gather with loved ones, it also serves as a reminder that we still have a long way to go to protect Colorado's big cats.

The holidays are the beginning of the Colorado mountain lion trophy hunting and bobcat trapping seasons in Colorado. And December also marks the anniversary of the death of the beloved and highly adaptable P-22, a California mountain lion who captured the heart of a nation with an iconic photograph against the backdrop of the Hollywood sign. CATs members wrote a beautiful tribute to him that was published in national news outlets; you will find links to those in the Media section below.

As the writers noted, this is a time to honor P-22 and be inspired by the love and appreciation for the "Brad Pitt" of mountain lions. Once people understand that lions are individuals, then we trust they'll extend their compassionate instincts to all lions and support policies to stop cruel and unsporting exploitation of these magnificent creatures. We hope his memory serves as motivation to protect the extended family of lions throughout the West, including Colorado!

### Updates

Currently, CATs has filed two very similar initiatives in Colorado, Initiative 91 and Initiative 101, to protect mountain lions, bobcats, and Canada lynx. We've done so to protect our interest, in the off chance that the trophy hunters' legal challenge to the first measure before the Colorado Supreme Court succeeds. We are defending Initiative 91 in the Colorado State Supreme Court this month, then attending Colorado Title Board hearings for Initiative 101 on December 20th and January 3rd. We will keep you up to date as we advance through the initiative process.


