This resonates with me, as our work today, at this moment, is to compel the commissioners to choose wisely for wildlife, and to make the needed reforms from the CATs Prop 127 effort.

Our guest, Bob Dean, a wildlife photographer, makes great points on air saying we can buy synthetic coats and no one needs to buy fur. You will hear me add: the way bobcats and other animals born with fur are killed — injected with acetone and drowned — is appalling.

In this bright moment, let's all take a breath because people on opposite sides actually found common ground. For cats. This is what makes CATs so powerful. We are building bridges and changing minds in real time.

I promise you that our work together to end fur trapping, as well as to end trophy hunting of mountain lions and bobcats, is going to succeed. All we need to do is keep the momentum going, together, as CATs undivided.

Because no one else is doing this specifically targeted work in quite the same powerful way as we are today. We have everything we need for success, and that is at the core, each one of YOU.

You can feel proud, for instance, that at the last CPW commission meeting, we had 77 citizen voices speaking in support of protecting our mountain lions, bobcats and wolves from cruelty, while just 44 voices tried to dismantle wolf restoration.

On the media front, our next Wildlife First guest is lined up and will be a wonderful surprise! I cannot wait to tell you. So hold on until next time. And please send me any ideas for future podcasts. And comments afterward.
