- [Please tell your federal lawmakers that you are opposed to the federal anti-wolf bill, H.B. 845](#)

Click on this link above and send a letter today to your federal lawmakers to compel them to vote NO on a horrendous and terrible bill that will delist (remove protections) for grey wolves. If delisting occurs, we'll see more inhumane treatment of wolves.

Also call the U.S. Capitol switchboard at 202-224-3121 to contact for your U.S. representatives and senators to ask them to oppose the delisting of grey wolves.
